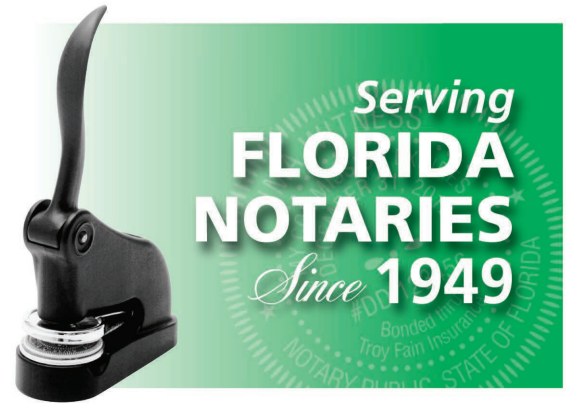

REMOTE ONLINE NOTARY REGISTRATION

Florida notaries may register to perform remote online notarizations (RONs) using audio-video technology standards that meets the requirements set forth in Florida law. We make it easy to get everything you need for your notary commission and to register as a remote online notary!

FOLLOW THE SIMPLE INSTRUCTIONS BELOW:

APPLICATION - Fill in all blanks, including your Driver's License and Social Security numbers. Have your character witness, someone who has known you at least one year and is unrelated to you, sign at the **Blue X**.

ONLINE NOTARY BOND - Print your name and sign at the **Red X**. Leave all other fields blank.

ONLINE NOTARY EDUCATION - First-time applicants must complete the required online notary course. Select one of the First-Time Notary package below – or find it online at: www.TroyFain.com. Be sure to send us a signed copy of the course completion certificate when you are done. **This course is for the traditional notary commission and does not fulfill the remote online education requirement.**

ORDER FORM & PAYMENT - Select a notary package or build your own using the Order Form (on reverse). Don't forget to protect yourself with Errors & Omissions insurance. Return your completed forms and payment to our office. We'll do the rest.

Troy Fain Insurance will hand-deliver your application to the State of Florida. Once your notary commission has been processed, you will receive an email with the steps for completing the registration process with the State directly.

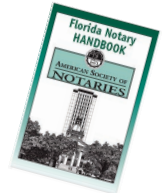

MEMORANDUM

AS A GENERAL MATTER, APPLICATIONS FOR ALL POSITIONS WITHIN STATE GOVERNMENT ARE PUBLIC RECORDS, WHICH MAY BE VIEWED BY ANYONE UPON REQUEST.
